### **Position Overview:**

We are seeking a dedicated and culturally grounded Indigenous Arts and Cultural Revitalization Coordinator for a limited term position supporting a multi-faceted initiative focused on sustainable forestry, woodworking, and cultural education. This role will lead efforts to integrate Indigenous knowledge systems, artistic traditions, and cultural teachings into programming related to wood harvesting, carving, and forest-based arts. The Coordinator will collaborate with community members, artists, and educators to strengthen intergenerational knowledge transfer and promote cultural renewal through land-based learning, and other duties as assigned.

# **Key Responsibilities:**

### Cultural Programming & Community Engagement (50%)

- Design and implement culturally relevant programs that connect Indigenous art, storytelling, and spiritual practices to the use of wood and forest resources.
- Collaborate with Elders, Knowledge Keepers, and artists to host workshops in traditional carving, regalia-making, basketry, canoe building, or other wood-based cultural practices.
- Organize community events, seasonal ceremonies, and land-based learning activities aligned with traditional calendars and teachings.

### **Curriculum Development & Integration (30%)**

- Co-develop curriculum and educational modules that incorporate Indigenous perspectives into forestry, woodworking, and ecological stewardship.
- Work alongside the Forestry and Sawmill Operations Manager to embed cultural values and protocols into technical training.
- Produce educational materials, documentation, and guides that preserve and share Indigenous cultural practices related to wood use and forest relationships.

### **Collaboration & Capacity Building (20%)**

- Support partnerships with local nations, tribal organizations, cultural centers, and Indigenous artists to amplify the project's impact.
- Help mentor youth and emerging cultural leaders by fostering pathways into cultural and artistic careers.
