 - iii. Pad to achieve 95% compaction under building and 90% compaction under parking areas
 - 1. Compaction to be verified by Tribal consultant via Nuclear Gauge
 - iv. Materials to be approved before import
 - b. Building 6' perimeter pad elevation to match Control Point #5 elevation
 - c. Building interior pad elevation to be 24" below Control Point #5 elevation
