#### JOB SUMMARY

The Seasonal Environmental Program Assistant, based in the Environmental Department, supports various environmental initiatives for up to 29 hours per week until September. Collaborating with field supervisors, the assistant learns departmental functions and team responsibilities while assisting with projects such as air and water quality monitoring, solid waste management, composting, general garden activities and more. The role involves conducting fieldwork, data collection, data entry and fostering teamwork. Additionally, the assistant will help with Sustainability Department Priorities.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- Conducting Air Quality monitoring activities, which may involve using specialized equipment and following established protocols.
- Assisting with Solid Waste management priorities, such as waste characterization studies, and recycling program coordination.
- Contributing to Data collection and entry processes, ensuring accuracy and adherence to data management standards.
- Assisting with Water Quality monitoring, including sample collection, analysis, and data interpretation.
- Performing duties in the garden, which may include soil sampling, plant health assessments, and implementing sustainable gardening practices.
- Supporting Fisheries Monitoring efforts through field work, data collection, and habitat assessments.
- Attending ongoing technical trainings as required by staff to enhance skills and knowledge in environmental sciences.
- Completing program evaluation surveys to provide feedback on program effectiveness and areas for improvement.
- Maintaining detailed records of hours worked, skills acquired, and project statuses for reporting and accountability purposes.
- Recognizing the role as a technical team member, understanding responsibilities, and practicing effective time management.
- Cultivating patience and understanding of the technical aspects of the mentoring relationship with supervisors and team members.

- Communicating effectively with assigned mentoring supervisor(s) via telephone or email regarding attendance and project updates.
- Collaborating with other BLR staff on joint technical projects serving multiple programs to gain teamwork experience and achieve technical objectives.
- Mentoring high school interns by providing technical guidance, training, and support in environmental monitoring and project implementation, fostering their interest and skills in environmental sciences.
- Other duties as assigned.
